1. The undersigned homeowner/tenant (circle one) hereby rents _____ automated recycling container(s) from Ace Disposal Inc.

2. The container(s) shall be used at the following address:

3. The undersigned agrees to rent the recycling container for the following term:

- ___ six (6) months at the rate of \$5.41 per month, for a total of \$32.46
- ___ twelve (12) months at the rate of \$5.09 per month, for a total of \$61.08

Payment in full is required up front for the length of term chosen.

- 4. The agreement may be terminated by contacting Ace Disposal at 229-1577 to arrange for collection, or by returning the container to Ace Disposals Office at 2274 South Technology Rd, West Valley City, Utah 84119. Upon termination, Ace Disposal shall have the right to enter on the user's premises and remove said container(s).
- 5. The undersigned agrees that the container(s) is/are in good condition and shall be responsible for any and all damage to the container(s), including replacement cost. Reasonable wear and tear is excepted.
- 6. The undersigned shall not remove the recycling container(s) from the premises at any time.
- 7. The undersigned agrees to use the recycling container only in compliance with the rules and regulations of the recycling program. The container shall be used for the disposal of paper, cardboard, plastics, aluminum, and tin only. **Glass is not permitted** in the container.
- 8. The undersigned agrees that if the rules of the recycling program are violated three (3) times within the 12-month period, Ace Disposal may retrieve the recycling container; and the agreement shall be violated. There will be no refund for any portion of the initial 12-month agreement period.
- 9. The undersigned acknowledges that the recycling container(s) is the sole property of Ace Disposal, Inc.
- 10. The undersigned agrees that Ace Disposal, Inc. shall not be liable for any loss, damages, injury (including death), or other casualty of whatever kind, or by whomever caused, to the person or property of anyone on or off the premises, arising out of or resulting from the owner's or other's use or misuse of the recycling container(s).

11. The undersigned agrees to pay all costs regarding the enforcement of this agreement including court costs and reasonable attorney's fee.
12. The established monthly rental rate may be amended periodically by action of Ace Disposal upon proper notice and with thirty (30) day notice to the homeowner of the amended rental rate. Said notice may be given by publication in a newspaper of general circulation within the city, by written notice sent to the address listed, or by publication and mailing.
13. The owner must sign the form on the line below. If you are **not** the owner of this property, please have this agreement signed by the homeowner. The property owner has the responsibility to cancel this agreement and will ultimately be responsible for all costs not paid by the tenant. Can will not be delivered until this agreement is signed and sent back to Ace Disposal.
